4 First-aid measures

4.1 Description of first-aid measures

After eye contact

Rinse immediately with tap water for at least 10 minutes, keeping the eyelids open.

Move the affected person to fresh air and keep them calm; seek medical attention if symptoms occur.

7.1 Precautions for safe handling

Processing in closed systems, if possible under inert gas (e.g. nitrogen). Local exhaust ventilation required; take measures against electrostatic charging; avoid dust formation (high risk of dust explosion).

Suitable materials: stainless steel, coated steel (protective coating), glass, polyethylene, polypropylene, enamel and acid- and alkali-resistant materials.

Unsuitable: aluminium, copper, zinc, iron.

Store in non-metallic, tightly sealed containers. Store in a cool, dry place away from light. Suitable packaging materials: tightly sealed; coated steel (protective coating), glass, polyethylene, polypropylene, PVC.

Air limit value: IOEL – 10 mg/m³ (8-hour TWA).

Analysis: Sampling on glass fibre filter and gravimetric or chemical determination.

Prolonged storage may cause yellowing due to slow degradation; in aqueous solution, the substance is prone to oxidative degradation, especially in the presence of alkalis or heavy metal ions.
